In addition to EU legislation, the Commission:

- engages with experts from EU countries in the [Public Sector Information expert group \(PSI Group\)](https://digital-strategy.ec.europa.eu/en/library/public-sector-information-group-main-page) (<https://digital-strategy.ec.europa.eu/en/library/public-sector-information-group-main-page>);
- funds an [Open Data incubator](http://opendataincubator.eu/) (<http://opendataincubator.eu/>) assisting small and medium-sized enterprises in building sustainable business ideas on the basis of Open Data;
- funded the [Legal Aspects of Public Sector Information \(LAPSI\)](https://digital-strategy.ec.europa.eu/en/news/legal-aspects-public-sector-information-lapsi-the-matic-network-outputs) (<https://digital-strategy.ec.europa.eu/en/news/legal-aspects-public-sector-information-lapsi-the-matic-network-outputs>) — thematic network of lawyers specialising on PSI re-use, including academics and practitioners;
- commissioned studies on the following issues:
  - Presence of [exclusive agreements](https://digital-strategy.ec.europa.eu/en/news/exclusive-agreements) (<https://digital-strategy.ec.europa.eu/en/news/exclusive-agreements>) in EU countries;

- Studies on the [economic potential](https://digital-strategy.ec.europa.eu/en/news/economic-analysis-psi-impacts) (<https://digital-strategy.ec.europa.eu/en/news/economic-analysis-psi-impacts>) of PSI re-use.
- developed an [Open Data Portal](https://data.europa.eu/euodp/en/home) (<https://data.europa.eu/euodp/en/home>) for its own documents and a [pan-European digital service infrastructure](https://www.europeandataportal.eu/) (<https://www.europeandataportal.eu/>) aggregating content of existing open data portals inside the EU;
- contributed to the G8 process on opening up government information, also for re-use, leading to the adoption of a [G8 Open Data Charter](https://www.gov.uk/government/publications/open-data-charter/g8-open-data-charter-and-technical-annex) (<https://www.gov.uk/government/publications/open-data-charter/g8-open-data-charter-and-technical-annex>).
