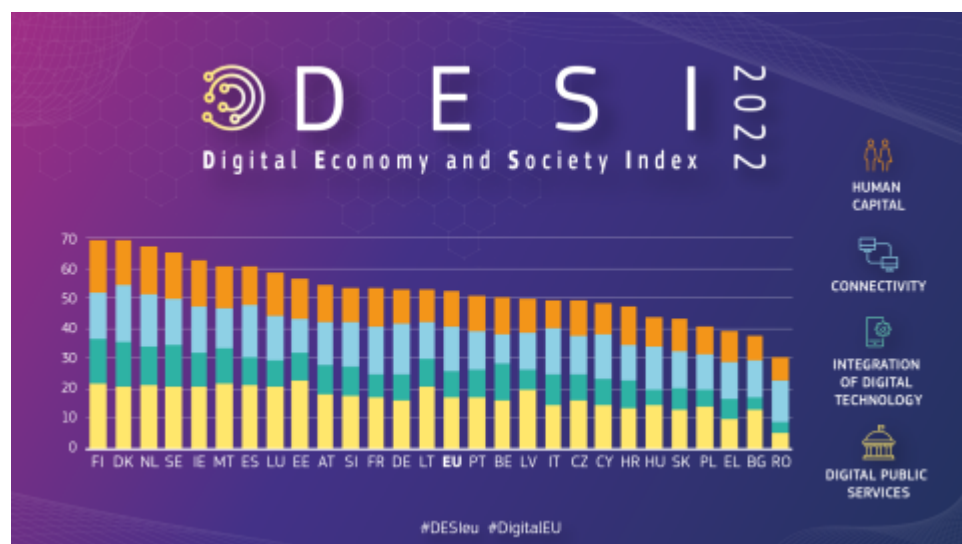

Le DESI a été recalculé pour les années précédentes afin de tenir compte de l'évolution du choix des indicateurs répartis entre 4 dimensions du DESI (nouvelle structure DESI), des corrections apportées aux données sous-jacentes et du recalcul de la moyenne de l'UE (suppression du Royaume-Uni). Les notes et les classements peuvent donc avoir changé par rapport aux éditions précédentes.
