

[Annual country reports on Open Internet from national regulatory authorities - 2020](#)

The European Commission has published the annual country reports from National Regulatory Authorities (NRAs) on compliance with the provisions on open internet for the fourth consecutive year. The NRA reports are provided every year to the Commission and the Body of the European Regulators for Electronic Communications (BEREC). The fourth set of reports covers the timeframe from 1 May 2019 until 30 April 2020.

These reports will serve as a basis for BEREC's Report on the implementation of the open internet rules expected by the end of the year. According to the EU open internet rules ([Article 5 of Regulation \(EU\) 2015/2120](#)), NRAs should closely monitor and ensure compliance with the provisions on open internet. NRAs are requested to publish annual reports and share these with the Commission and BEREC.
