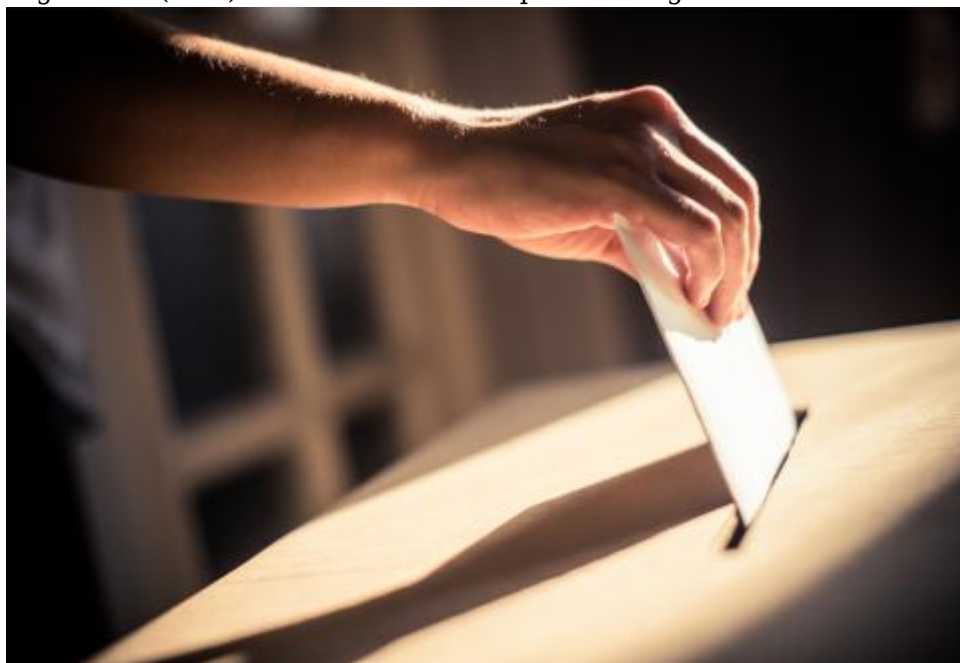

Is iad sin na chéad treoirlínte riamh faoi Airteagal 35 den Ionstraim um Sheirbhísí Digiteacha agus is é is aidhm dóibh ardáin an-mhór ar líne agus Innill Chuardaigh a chur i láthair le dea-chleachtas agus bearta féideartha chun rioscaí sistéamacha ar a n-ardáin a mhaolú, rioscaí a d'fhéadfadh sláine na bpróiseas toghchánach daonlathach a chur i mbaol.

Soláthraítear sna dréacht-treoirlínte samplaí de bhearta maolaithe a d'fhéadfadh a bheith ann a bhaineann le rioscaí a bhaineann le toghcháin, bearta maolaithe sonracha atá nasctha le hábhar Gineach intleachta saorga, bearta maolaithe riosca a phleanáil roimh imeacht toghcháin nó ina dhiaidh agus treoir shonrach do thoghcháin Pharlaimint na hEorpa.

Faoi Airteagal 35 den Ionstraim um Sheirbhísí Digiteacha, féadfaidh an Coimisiún, in éineacht le Comhordaitheoirí Seirbhísí Digiteacha na mBallstát, treoirlínte a eisiúint maidir le rioscaí sonracha, chun dea-chleachtas a chur i láthair agus bearta maolaithe féideartha a mholadh. Is féidir aiseolas a thabhairt faoin gcomhairliúchán taiscéalaíoch go dtí an 7 Márta 2024.
